2026 GROUPS CONDITIONS

BOOKING CONDITIONS

→ From 20 people:

- Group booking is mandatory by sending the booking form filled in timeslots from
 9am. Please respect the confirmed time.
- No group booking over 20 people online. Any reservation that does not comply with the rules may be refused entry.

→ Under 20 people:

- o Tickets under 20 people must be **booked online**. timeslots from 10am.
- Online ticketing: strictly reserved for individuals and small groups.
- o Free admission conditions for individual visitors are available on our website.

→ National bank holidays:

- No group bookings after 2pm on these dates.
- o Online ticketing is limited on peak dates book your tickets in advance.

PAYMENT CONDITIONS

- \circ Payment on spot at the groups entrance by credit card. \rightarrow No cash payment.
- Bank transfer depending on the agreement of the group service.

ACCESS CONDITIONS

- \circ Open every day from April 1st to November 1st from 9am to 5pm for groups.
- o Group bookings are required from 20 people.
- o The visit of the house and gardens takes from 1h30 to 2 hours (not guided).
- o It is possible to visit with an independent guide: list of independent guides.
- We do not provide individual prepaid tickets to agencies.
- o <u>People with disabilities:</u> The gardens are wheelchair accessible (but not the house). Wheelchairs are available upon request at the entrance.

VISIT RULES

ACCESS TO THE SITE

- Map of the house and gardens
- o Drop-off point: free coach park at the parking lot "la Prairie" at 5-minute walk from the group entrance. It is not allowed to drop off visitors on the road.
- o Free and open-access car parks are available in Giverny.
- o Free public toilets on the way at the parking lot "the Verger".

VISIT CONDITIONS

- Any exit of the house and gardens is final; the ticket is valid for one access only.
- o It is not allowed to draw or paint in the house or in the gardens.
- No privatization of the house and gardens.
- Animals are not allowed.
- o Large luggage is not allowed (Vigipirate plan).
- o <u>Independent guiding:</u> only licensed tour guides are authorized to provide commentary, and only within the gardens. No fee for speaking rights is required.

Tour leaders are only authorized to guide their clients without providing commentary and with respect for other professionals.

We do not offer audioguides.

SCHOOL GROUPS

- o Educational kit to download
- We do not organize workshops.
- Please make sub-groups before your arrival.
- Leave your backpacks or picnic bags in the bus.
- Picnics are forbidden: Plan your picnic before or after the visit (green areas in Giverny next to the school or in front of the restaurant "Baudy" no covered shelter).
- Respect of the area and proper attitude are required. The accompanying adults must supervise the children all along the visit. In case of disrespect of the rules, we will ask the group to leave the house or gardens.
- Please do not obstruct the paths and opt for a gathering at the exit of the site.
